A literatura ainda é incipiente quanto a análise sobre o papel das estratégias comerciais, financeiras e de investimento para integração entre grandes países de renda média. Nesse contexto, as pressões comerciais sobre as commodities energéticas e o uso do sistema financeiro como alavancas geopolíticas tem disparado ondas de choque sobre os arranjos globais do capitalismo. Por isso, os espaços para a criação de mecanismos de coordenação financeira e comercial entre as economias de renda média tem sido abertos. Exemplos disso são os acordos bilaterais de swap entre bancos centrais, os novos bancos multilaterais de desenvolvimento e infraestrutura, além dos sistemas de pagamento interbancário concorrentes ao SWIFT. Todos constituem um recente arcabouço regulatório que busca criar margens de manobra financeira fora do arranjo de Breton Woods. Esse curso pretende explorar esse arcabouço de integração financeira, o papel dos recursos energéticos, efeitos institucionais sobre a democracia e a proeminência da China e Rússia para criação de uma infraestrutura geoeconômica competitiva.
